CONTRACTS AND AGREEMENTS FOR FISCAL YEAR 2023-2024:

MH Amendment Agreements: FY 23-24

Mr. Wagner noted Robert Castellano provides mental health and suicide assessments for inmates at the Lycoming County Prison. Mr. Castellano only works a few days per week and the agency has since hired a full-time staff member to work within the prison. The decision was made to extend Mr. Castellano's agreement to 03/31/2024 until the new hire can begin. Commissioner Russo Moved and Commissioner Metzger Seconded a Motion to:

The Motion passed unanimously.

Mental Health Services: FY 23-24

Mr. Wagner presented one agreement for mental health services with Salisbury Behavioral Health dba PAHrtners Deaf Services. This agreement is to provide long term residential services for a deaf client. This is a specialty service and is primarily paid for using funding from CHIP. Commissioner Russo Moved and Commissioner Mussina Seconded a Motion to:

"Approve the following New Agreement pertaining to mental health services with the Lycoming-Clinton Mental Health/Intellectual Disability Program for the period 11/6/23 to 6/30/24:

New Agreement for Long Term Residential Services \$88,103; 11/6/23 to 6/30/24."

The Motion passed unanimously.

Intellectual Disability Services: FY 23-24

Mr. Wagner presented four renewal agreements for Intellectual Disability (ID) services. Commissioner Mussina Moved and Commissioner Metzger Seconded a Motion to:

"Approve the following Renewal Agreements pertaining to intellectual disability services with the Lycoming-Clinton Mental Health/Intellectual Disability Program for the period 7/1/23 to 6/30/24:

Renewal Agreement to be Vendor Payer for Base Intellectual Disability Services \$1,500 (decrease of \$1,000); 7/1/23 to 6/30/24

Renewal Agreement for Home and Community Habilitation, Supported Employment, and Other Services \$30,000 (decrease of \$28,500); 7/1/23 to 6/30/24

• Onewell, LLC

Renewal Agreement for Community Supports and Companion Services \$5,000 (decrease of \$100); 7/1/23 to 6/30/24

Pediatric Services of America, d/b/a Aveanna Healthcare

Renewal Agreement for Home and Community Habilitation and Companion Services \$1,500 (decrease of \$13,500); 7/1/23 to 6/30/24."

Keith Wagner presented an amended contract with Community Care Behavioral Health. This contract pertains to HealthChoices and has no significant changes from the prior year. Commissioner Russo Moved, and Commissioner Mussina Seconded a Motion to:

The Motion passed unanimously.

Lycoming-Clinton Joinder Brard Behavioral HealthChoices

Overview

February 2024 Joinder Board Meeting

HealthChoices (HC) Role:

- HealthChoices is responsible for Oversight of the dollars allocated for Behavioral Health services, including Mental Health (MH) and Substance Use Disorder (SUD) services for citizens that have Medicaid in Lycoming and Clinton counties.
- Under the program, counties are required to ensure high quality care and timely access to appropriate mental health and drug and alcohol services and facilitate effective coordination with other needed services. The HealthChoices Behavioral Health Program was implemented statewide on July 1, 2007.

Behavioral Health Managed Care Organization (BH-MCO) (CCBH)

PROVIDERS

The Commonwealth of Pennsylvania's mandatory Medicaid managed care program, called HealthChoices (HC), is the largest Medicaid program administered by the Department of Human Services (DHS) and consists of three components. The Office of Medical Assistance Programs (OMAP) administers two components: the Physical Health Program and the HealthChoices Enrollment Assistance Program. The Office of Mental Health and **Substance Abuse Services** (OMHSAS) oversee the third component, the Behavioral Health Program that provides mental health and substance abuse treatment services.

HealthChoices (HC) is considered the Primary Contractor (PC) and holds the contract with OMHSAS and complete responsibility for the program. HC includes 5 primary staff. HealthChoices also supervises the CASSP Coordinator. The HealthChoices program, overall, is then administered by the Commissioners of the Joinder.

OMHSAS requires that the PC has a downstream contract with a BH-MCO and HC, through a procurement process, chose CCBH. Through this contractual process, CCBH reports back to HC around requirements detailed in the contract such as claims processing, member outreach, quality and care management. In turn, HC staff is responsible for Oversight of the MCO and reviews the work that is being done by CCBH to be sure that they are reaching the outlined goals and requirements. We partner in many ways with CCBH, but at the end of the day, HC as the PC is responsible to make decisions and direct services. We are required to follow all state and federal mandates, but within that framework, there is a lot of local choice.

Providers contract directly with CCBH, so many of the day-to-day activities flow through CCBH. HC has overall oversight and direction of the contracts. A provider can and should reach out to HC at any time that they feel that there are barriers to providing services. CCBH and HC then partner together to work on the barriers and HC is routinely in contact with Providers.

Medical Assistance (Medicaid) General Eligibility Requirements

You must meet income, resources (in some cases), and other eligibility requirements to be eligible for Medical Assistance. One of the "other eligibility" requirements includes persons with Disabilities. A disability is any condition of the body or mind (impairment) that makes it more difficult for the person with the condition to do certain activities (activity limitation) and interact with the world around them (participation restrictions).

Medical Assistance (MA), also known as Medicaid or MA, pays for health care services for eligible individuals. This includes Mental Health/Substance Use Services.

Lycoming/Clinton Behavioral HealthChoices (LCBHC) pays for Medicaid (MA) Mental Health (MH) and Substance Use Disorder (SUD) costs for residents of Lycoming and Clinton Counties that are enrolled with the Managed Care Organization (MCO) selected by LCBHC. The name of the MCO is Community Care Behavioral Health (CCBH).

Financial Information:

- The Lycoming-Clinton HealthChoices program has a budget of around 61.1 million dollars and those funds come directly to HC. The funds are completely made up of State dollars and there is not a county match. Also, use of the funds is restricted to services for citizens of Lycoming or Clinton County who have Medicaid and have the CCBH benefit as determined through the local county assistance offices.
- Of those dollars in 2023, 20% went back to the State as required for MCO assessment, 0.6% went as payments to CBCM. Of the remaining dollars, 67.6% went directly to providers, 2.4% was used for HC administration, 8.4% covered CCBH administration and claims processing, 0.8% CCBH incentive award, and the remaining 0.2% will be used for reinvestment programs and to increase risk and contingency.
- CCBH holds most of the risk. In a worst-case scenario, HC has an account which holds Risk and Contingency funds. If claims come in above the risk threshold set for CCBH, these funds can be used. There is little, if any, risk to the Counties.
