He noted that Ms. Lake was the Executive Director of Dwell Orphan Care and has been appointed to the CYS Sub-Committee.

2022-2023 CYS/JPO NEEDS BASED PLAN OVERVIEW:

Mr. Salvatori noted that Mark Longenberger - CYS Support Services Director; Matt Wood - CYS Clinical Director; and Dave Goodwin - Chief Juvenile Probation Officer were present to assist with the presentation and answer any questions that may arise. They provided a power point presentation of the CYS/JPO Needs Based Plan Budget document. The Plan was reviewed in detail emphasizing future initiatives for JPO and CYS.
